The clubs are looking to move the event location and weekend next year in hopes to draw more members and guests. If you would like to help or be part of our vendors next year please contact

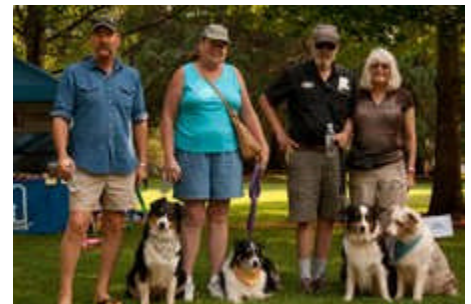

Dr. Lorain represented the Staffordshire Bull Terrier and Whippet breeds. We also had representatives from Dogs for the Deaf, our local humane society and animal control.
